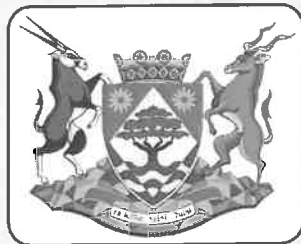

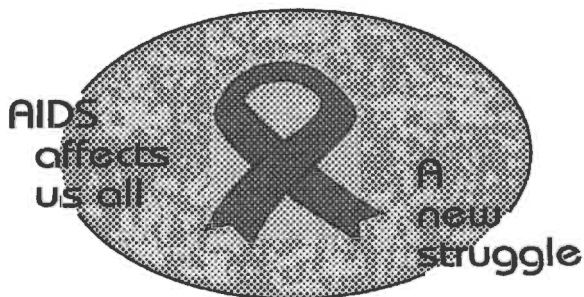


I, **Dr Zamani Saul**, in my capacity as Premier of the Northern Cape and in line with the provisions of section 59(1) (a) of the Northern Cape Traditional Leadership and Governance and Houses of Traditional Leaders Act (Act No. 2 of 2007); read with section 2 of Northern Cape Commissions of Inquiry Act (Act No. 4 of 1996) **hereby appoint a Commission of Inquiry ("the Commission")** to investigate traditional leadership disputes and claims arising out of John Taolo Gaetsewe District, Northern Cape Province.

SCHEDULE

TERMS OF REFERENCE

1. PURPOSE

The Commission shall enquire into, make findings, compile a report with recommendations on the traditional leadership disputes and claims in John Taolo Gaetsewe District, Northern Cape Province. In doing so it shall be guided by, *inter alia*, the Constitution of the Republic of South Africa, Sec 59(1) of the Northern Cape Traditional Leadership Governance and Houses of Traditional Leaders Act (Act No. 2 of 2007); Northern Cape Commissions of Inquiry Act (Act No.4 of 1996) and regulations issued thereto.

2. CONDUCT OF THE COMMISSION

The Commission shall accept any representations whether oral or in writing made by any person who has a legitimate claim to a traditional leadership position in the John Taolo Gaetsewe District, Northern Cape.

3. DURATION

The Commission shall conduct and finalise its work within 24 months from date of publication of this notice.

4. VENUE OF THE COMMISSION

John Taolo Gaetsewe District, Kuruman

5. REMUNERATION OF COMMISSION MEMBERS

The members of the Commission who are eligible for compensation shall be remunerated in accordance with National Treasury Guidelines.
