Notice is hereby given that the Office of the Premier is in process of reviewing and expanding the Spatial Development Framework in terms of the Spatial Planning and Land Use Management Act (Act 16 of 2013) and that the concept report is available for public input for the period of 60 days.

The Spatial Development Framework is a strategic document setting out objectives reflecting the desired spatial and form for the Province, as well as identifying strategies and policies through which to achieve such objectives. Further details and complete documentation are currently available for input to the general public and copies of the concept reports are available the Office of the Premier. The Town Planning firm, Maswana Joint Venture, has been appointed by the Office of the Premier to review the PSDF.

Interested and affected parties are hereby invited to submit written representations, in terms of Section 15 (6)(b) of the Spatial Planning and Land Use Management Act (Act 16 of 2013), in respect of the proposed review of the Northern Cape Provincial Spatial Development Framework, to the Office of the Premier from the 1st October 2018 to 30th November 2018.
